

SCHOOL BOARD CONTINUING EDUCATION RECORDS  
HUGHES SPRINGS ISD

Due to changes by the State Board of Education (Rule 19 Texas Administrative Code 61.1) and Senate Bill 1566 (85<sup>th</sup> Legislature) regarding the manner for reporting continuing education for school board members, the required hours earned, or deficit must now be posted on the District's web-page.

The change mandates reporting of continuing education during the month preceding the election for school board members instead of during the month of December of each year. This change creates a transition period of less than twelve months for the current terms in which trustees may appear to be deficit when actually they are not. Trustees will have more time following the election to complete the education requirements. Following this current year, all trustees will have twelve months to complete all their required training.
